Due to the fact that the Covid restrictions continue until 19 July 2021 the Mass of Confirmation and First Holy Communion will have to be restricted to only those receiving Confirmation and First Holy Communion only. The limit on attendance is the safe capacity of the Church building in our case 30.

Thank you for your understanding and for putting our children first – please make other arrangements for **THURSDAY 15 JULY AT 7:30PM** and for **SUNDAY 18 JULY 09.30AM** – thank you.

PLEASE KEEP in your thoughts and prayers the children who are involved in our sacramental preparation this year. Alexander and Angelina who will make their First Confessions on Saturday 17 July and Martha, Florence, Layla, Sol, William B, William H and Angelina who will make their First Holy Communions on Sunday 18 July. Due to restrictions they will only be celebrating with their families, but hopefully later in the year we will be able to hold a Presentation Mass whereby the parish will be able to share in their experience.

FAITH & REASON A Catholic Integration will run from Thursday 5 to Sunday 8 August. The 3-day course will be led by two excellent and experienced lecturers and tutors, who have taught at the Maryvale Institute for many years and worked with many dioceses and seminaries around the UK and abroad. The course will offer lectures and discussion around common themes related to the rationality of the Catholic Faith, dealing with many frequently-asked questions, for example around the relationship of faith and science. We are offering residential options as well as non-residential, for those more local and wishing to drive in daily. The course will go ahead assuming the lifting of Covid restrictions in July. GUIDANCE ON COVID The Prime Minister confirmed his intention from 19 July to reopen all remaining businesses, lift limits on gatherings and lift the bulk of rules on wearing a mask. This is a profound shift in attitude from the government. While no final decision on what happens on 19 July will be made until 12 July, the PM said it was time to move away from 'legal restrictions and allow people to make their own informed decisions'. While face masks will no longer be mandatory, the PM suggested that there will still be settings where it would be a good idea to wear one.

Chief Medical Officer Chris Whitty and Chief Scientific Officer Patrick Vallance went further. Chris Whitty said that with cases on the rise, a mask would be a good idea in indoor settings with people you don't know. On this point, Patrick Vallance backed him up.

In light of the announcement from the government that covid restrictions are to be largely lifted from the 19 July, the parish council are meeting on the 20 July to consider how to safely open the church for Mass. We do not expect a return to the normal pre lockdown situation in the first instance but will keep everyone informed as soon as we can as to what the arrangements will be.

Face Coverings are required by law to be worn in places of worship up to 19 July. The presiding celebrant in the sanctuary, providing they are sufficiently distant (2m or more) from the congregation, does not need to wear a face covering.

Limitation on Numbers Attending Mass should be maintained until 19 July: The 2m social distancing requirements should be applied wherever possible. Good ventilation of the sacred space (especially during and between services) remains important.

Managing Church Access Parishes should continue to operate the registration arrangements for those wishing to attend the celebration of Mass and at liturgies where the numbers need to be restricted to the safe capacity of the church. QR Codes & Booking systems should be in place.

Congregational Singing remains suspended - to be kept under review.

The Communion Rite The Sign of Peace remains suspended - to be kept under review. **Cleaning of Churches** General cleaning to a good standard, with attention to frequent touchpoints to continue. If someone has tested positive for Covid-19 who has used our church premises in the last 24 hours, then should ensure the building is cleaned thoroughly using ordinary detergents. A "deep clean", is not necessary.

REMEMBER, if your health is not good and you are vulnerable, if you have a cough or cold or temperature you should stay at home.

These are journeys we make because, at some level, we feel we must make them.

Something within us moves us to certain path, to head out in a certain direction. Even though we sense the journey may be difficult, and we may have all kinds of hesitations and reservations about it, nonetheless, we know we have to set out on this path, if we are to be true to ourselves. Yes, we choose to make such a journey, but it is a choice in response to what seems like a call from beyond ourselves or from deep within ourselves.

Such a journey is put before us in today's first reading. Amos was a shepherd and a dresser of sycamore trees in the southern kingdom of Judah. He felt compelled to make a difficult journey into the Northern kingdom of Israel in order to preach the word of God there. It was a most unlikely journey for the likes of Amos. Yet, he also knew that this was a journey he simply had to make. He said 'The Lord... took me from herding the flock and... said "Go".' Amos went. In a similar way, in the gospel, the disciples set out on a journey because they are sent on that journey by Jesus. They set out freely, but in response to a call, a sending.

The experience of Amos and the disciples can be our experience too, setting out on a journey not completely of our choosing. The second reading says that God wants us to live in a certain way, to live our life's journey as Jesus did. Although we often make all kinds of journeys of our own choosing, whether holidays or business or other trips, there is sense in which we try to allow God to guide us to take certain paths and to avoid others, moving us in one direction rather than another. – 'before the world was made', according to St Paul – God wants us to also choose this journey for ourselves, and waits for us to do so. This is not a choice we make once and for all; it is one we are constantly remaking.

The Gospel today is saying two things to us: Each Christian is called not only to be a disciple but also to be an apostle. A disciple (discipulus, from the verb discere, to learn) is one who hears, who accepts and who carries out the teaching of Jesus in his/her life. A disciple follows Jesus, imitates Jesus, becomes a second Christ. An apostle (apostolos) is not only a follower but also an evangeliser. The word comes from a verb which means to be sent on a mission with a message from a superior – an ambassador, an envoy. Every person who has been baptised has this mission and this calling, actively to share their faith with others. We work with Jesus to help people find or recover their freedom.

All our lives we can keep on choosing to surrender to God's purpose for us; we keep setting out on the journey God is calling us to take. If we keep choosing the journey that God has chosen for us in Christ, responding to God's call, this will impact on the many smaller journeys we take in life. We will choose ways that help re-create the image of God's Son in us. We will live in ways that are life-giving for ourselves and for others, in ways that help us to become more fully the person God wants us to be...
